

**Divisions:** Open (O), any rider who does not correctly designate themselves as a Junior, Young Rider or Adult Amateur will automatically be placed in the Open Division. Junior (JR), classes open to riders through the calendar year in which they reach the age of 18. Young Rider (YR), classes are open to riders from the beginning of the calendar year they turn 16 years of age through the end of the calendar year they turn age 21. Adult Amateur (AA), classes are open to non-professional riders over the age of 21 who hold a current USEF Amateur card.

## Regional Adult Amateur Equitation Program

The USDF Regional Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. An Adult Amateur Equitation Regional Final class presented by Big Dee's Tack and Vet Supply will be held in conjunction with each of the nine USDF Regional Dressage Championship competitions, providing adult amateurs with additional opportunity for recognition. Ribbons awarded through 8<sup>th</sup> Place and gift certificates awarded to top four riders.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

#### **Qualifying Requirements**

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

a) Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDF-recognized Dressage competition within the qualifying period of the applicable regional championship.

<u>or</u>

b) Qualified to compete in any regional dressage championship class (excluding freestyles).

#### **Membership Requirements**

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

- Know the rules for the level you are riding. This includes forbidden and allowed movements for your level.

#### Fee Schedule:

Great American/USDF Qualifying Classes are an additional \$15 per class. Qualifying fees may be paid any time before the ride is ridden. One qualifying score per level can be earned during each show. USEF non-member fees apply for each non-member (rider, owner/agent, trainer, and coach if applicable.). USDF non-member fees apply to rider and owner only. There are exceptions for riders who are competing in classes on the exception list. The exception list can be found on the USDF website.

USEF Show Pass Fee: Effective 12-1-2022 any rider, handler, driver, or owner are limited to one Show Pass purchase annually (December 1-November 30). USEF Show Pass will be available for purchase by exhibitors on-line only. Competitions may not accept payment for show pass fees and therefore this fee should not appear on the entry blank. Individuals, including parents who are signing as trainer on behalf of a minor, who are participating as a trainer or coach are not eligible for a Show Pass and must obtain a Senior Competing membership to participate in a USEF-licensed competition.

**Entries:** No paper entries will be accepted. **All entries must be submitted online via www.foxvillage.com**. All required paperwork including USEF and USDF Membership cards, signatures, and proof of vaccination must be provided with your online entry. The show's preferred payment method is electronic payment via Stripe through the on line entry system. Personal checks by mail will be accepted and must be received by June 13th. If mailing a check, please include horse and rider name with the check. Make checks payable to **Millbrook Farms** and send with entry to **Show Secretary:** Jan Lawrence, PO Box 237, Cedar Fort, UT 84013.

# Entry Procedures: This is one show on Friday and a second show on Saturday/Sunday. Each show must be entered separately.

No entries prior to the opening date will be accepted. No entries will be accepted without payment in full included.

Completed entry forms must include copies of current owner/rider/trainer/coach memberships for USEF (or show pass/non-member fee), USDF (or non-member fee), RMDS and UDS as applicable, a copy of horse's Registration/Recording card or certificate; and a copy of a Coggins test taken within 12 months of the show dates must be presented for horses coming from out of the state of Utah. Entries missing any of these items will be considered incomplete. Adult Amateurs must include USEF Amateur Card or they will be entered into the Open division. Juniors and Young Riders must include their birthday on their entry form, or they will be entered into the Open division. All entry forms must have original signatures (rider, owner/agent, trainer, and coach if applicable). A parent or guardian must sign for any Junior under the age of 18.

Management reserves the right to limit the number of horses entered by an owner and/or the number of horses ridden by a rider.

Riders who wish to enter Great American/USDF Qualifying Classes, it is your responsibility to have the correct memberships and horse registrations. For more information on which memberships and registrations are required, please go to the USDF website www.usdf.org and look under the Competitions tab.

No post-dated checks accepted. If an NSF check is not promptly taken care of, the competitor will be reported as required to USDF and USEF.

Entries are accepted on a first-come, first-served basis, based on online submission date and entries may be limited. Those entries submitted after closing will be accepted at the discretion of the show secretary, based on a space available basis, and charged a late fee per show. If the classes are oversubscribed, a waitlist (in the order of receipt) will be maintained. Management reserves the right to refuse any entry.

**Entry Changes:** Any changes to an entry must be emailed to the Show Secretary, Jan Lawrence (millbrk@xmission.com) by June 13th. Change of horse or rider will constitute a new entry requiring change fees. Management reserves the right to refuse any entry.

**GAIG Qualifying Classes:** For the Great American/USDF Qualifying rides, riders must have an active USEF Membership and a USDF Participating Membership. Owners must have a USDF Participating or Business Membership and a USEF membership (Junior Active, Senior Active, Life, or Recorded Farm (with Active Farm Owner)). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF. Horses must be Annual or Lifetime Recorded with USEF and USDF Lifetime Registered, an HID is not sufficient. Great American qualifying entries must include horse USEF and USDF registration and rider's and owner's USEF and USDF card(s).

Please note that we will not accept cross-entering opportunity and non-opportunity classes for riders and/or horses.

Non-compete horses are allowed on grounds only with prior approval of show management and if space is available. Owner must fill out an entry form and pay office, non-compete fee, and stall fees, but no USEF drug fee. This competition is limited to horses and mules as per USEF rules. No companion animals of any kind will be allowed on the grounds. Other animals and livestock are not allowed on the show grounds.

**Official Ride Times:** Provisional ride times will be posted by June 24th on the <u>Millbrook Farms website</u>. The official show schedule will be posted by noon the day before the show in the office and on the <u>Millbrook Farms website</u>.

#### All Class or Rider change requests must be made by 11:00 AM the day prior to the class.

**Refund Policy:** Refunds less the office fee will be given from the opening date to the closing date. No refunds of any kind for any reason including Acts of God will be given after the closing date and throughout the competition unless rides are filled from the waitlist. The waitlist will be maintained through June 24th. Stabling will be refunded if the horse is scratched on or before June 24th or if the stall can be given to another competitor during the show.

**Hazardous Weather/Act OF God/Accident Policy:** Management reserves the right to cancel any classes due to hazardous weather, Acts of God, accident, or emergency. Every effort will be made to reschedule with priority given to any qualifying classes being offered. No refunds for cancellations due to hazardous weather, Acts of God, accidents or emergencies.

**Schedule:** Classes may not necessarily be run in the order listed in the class lists. It is the responsibility of the rider to inform the show secretary of any time conflicts as soon as possible after receiving the schedule. Management reserves the right to change officials, limit entries, combine or cancel classes, and modify the schedule, and to modify or cancel awards and/or make whatever changes are required by circumstances to the competition specifications listed herein. Show Management reserves the right to cancel classes insufficiently filled and to refuse or require withdrawal of an entry for cause deemed sufficient by Show Management.

#### All horses must always wear show numbers when out of stall.

**Scores:** It is the responsibility of the competitor to verify the accuracy of all scores. Scoring errors must be reported to the Show Secretary within one hour of the official posting of the scores from the last class of the show day during which the score was earned.

**Opportunity Classes:** Opportunity classes are intended for entry level riders. Horses and riders entered only in "Opportunity" classes are exempt from USEF and USDF membership requirements, and do not have to pay non-member (show pass) or HID fees. Federation and drug fees do not apply. Horses entered only in these classes are still subject to and must comply with the Drugs and Medication rules and are subject to drug testing. Riders and/or horses entered in "opportunity" classes may not cross enter into other recognized classes at the show. Participants must abide by all USEF regulations pertaining to attire, tack and equipment for the recognized show. Reference GR821 for additional information.

**Arena No Shows:** We reserve the right to fill all of a competitor's subsequent ride times if a competitor fails to notify the competition of his/her intention to scratch.

Freestyles/Music: Except for USEF/USDF Championship classes and for FEI Pony Riders, FEI Junior and FEI Young Rider Freestyles, in order to enter a freestyle class at any level, a horse/rider combination must have received a minimum score of 63% for Training through Fourth levels and 60% for FEI levels in the highest test of the declared freestyle level or any test of a higher level at a Federation /USDF Licensed Dressage Competition or FEI recognized Dressage Competition or "open" Dressage class (i.e. open to all breeds) at a Federation Licensed Competition held prior to the competition where the horse/rider combination is entered to ride a freestyle class. To enter an FEI Para Dressage Freestyle class, a horse/rider combination must have received a minimum score of 60% in any FEI Para Dressage test (Para Novice Test, Para Intermediate Test or Para Grand Prix Test) at the rider's classified Grade. This score may be earned at a USEF/USDF licensed Dressage Competition or FEI recognized Dressage Competition or "open" Dressage class (i.e. open to all breeds) at a Federation Licensed Competition held prior to the competition where the horse/rider combination is entered to ride a freestyle class. A photocopy of the test verifying eligibility, or copy of the USDF score verification, must be submitted with the entry for a freestyle class. All FEI Pony Rider Tests are equivalent to Second Level; all FEI Junior Tests are equivalent to Third Level; all FEI Young Rider Tests are equivalent to PSG; and the USEF Brentina Cup (Young Adult) Test and FEI Young Rider Grand Prix 16-25 Tests are equivalent to Intermediate II. For purposes of freestyle qualification, all are considered equivalent to the highest test of that level and may be used to enter a freestyle at that level or a level below. Young Horse and FEI Children Tests cannot be used for freestyle qualification at any level.

E-mail digital music file to Jan Lawrence (<u>millbrookfarmsagain@gmail.com</u>). Music for all freestyles must be given to the show office no later than noon on Thursday. (No CDs or thumb drives.) Sound checks will be conducted Thursday at 5 pm.

**Stabling:** Stabling is first-come, first-served with a complete paid entry. Stalls are all permanent, of substantial construction, at least 12' x 12', with rubber mats or packed dirt footing, with solid sides and doors. Outside paddocks with gates are available that may or may not have shelters. Bedding for all stalls will be provided and is included in the cost.

Tack stalls will only be available if regular stalls do not sell out, check with show management. No nails or staples are allowed to be affixed to any stalls. Zip ties are allowed. Hanging organizers are allowed as long as they are not nailed or stapled to the stall itself. All horse riders/owners must provide emergency contact information for horses stabled on site. We will make every effort to accommodate requests for stabling. Contact the Show Secretary Jan Lawrence via phone or email to discuss availability. Stalls are available the Thursday before the show through the Monday after the show. (Approximately 50 stalls available on site, not including paddocks.)

#### There is a \$40 penalty for switching horse stalls without notifying the Show Office in advance.

**Ribbons and Awards:** Ribbons for first through sixth place. Prizes for first place regardless of division. All Test of Choice, USEF, FEI, and Musical Freestyle classes will be pinned as one class regardless of division or level.

Ribbons and awards will be available for pickup near the show office.

**High Point Award**: High point awards will be given by Millbrook Farms for Training through FEI (one per level regardless of division). High point awards are personalized and will be delivered after the competition. There will be no formal awards ceremonies held. Separate high point awards will be given for each of the Musical Freestyle Classes. In addition, Jim and Donnette Hicks and Sage Creek Equestrian are sponsoring a \$100 cash prize to the highest scoring horse and rider of each show in regular dressage classes. (The highest scoring ride for Friday Classes 101-119 and 136-141 combined.) (Saturday/Sunday Classes 201-219 and 236-241 and 301-319 and 336-341 combined over both days.)

**Arenas/Footing/Warm-Up:** Two permanent 20m x 60m outdoor arenas with permanent judges' booths. One outdoor 70m x 70m warm up area and one 30m x 70m indoor arena warm up area. All arenas have excellent sand footing. For lungeing area, inquire at show office or warm up ring stewards. No lungeing in the warmup areas including the indoor arena. Grooms, trainers, coaches and friends must stay outside of the warmup arenas. Riders and horses always have the right of way during competitions. Hand walking and schooling will be allowed on Thursday until sunset. Friday and Saturday schooling will be allowed after the show ends until 8:30 pm. The arenas will be groomed the morning before the show begins, so no hand walking around the outside of the arenas will be allowed while the arenas are being groomed for the competition.

**Veterinarian:** Emergency phone numbers and information will be posted at the show grounds and on stall cards.

**Farrier:** A farrier will be on call each show day. Emergency phone numbers and information will be posted at the show grounds and on stall cards.

**Concessions:** Some food will be available for purchase on site. A list of nearby food vendors in Eagle Mountain City Center (15 minutes away) will be emailed to all competitors before the show begins. Hospitality spreads within your stable area are allowed. Water and snacks will be available for competitors.

Camping on site in self-contained units is allowed. We have limited electrical RV hookups for \$25/night. RV hookups are reserved through the facility by calling (801) 631-2516.

**Special Circumstances:** From time to time the livestock operation next door will be loading animals into trailers during our dressage shows. We have no control over the timing of their loading activities. Riders in either arena who are scheduled to be riding tests during the loading of livestock will be given the option of riding or holding in the warmup ring for a short wait while they get their animals loaded onto their trailers (typically 5-10 minutes). Riders who choose to take their ride at their scheduled time do so with the understanding that there may be distracting noises during their ride. There will be no penalty for electing not to ride while the livestock is being loaded although the show may be off the published schedule for a short time while the delay is being made up.

#### Reminders

This is a private facility. No dogs are allowed on the grounds.

An EMT will be on site during the competition and 30 minutes prior to the first ride.

Sharps containers are available, and their locations will be provided at check in.

There is no smoking allowed anywhere on the grounds.

Effective 12/1/18, **ALL** participants (riders, owners, trainers and coaches) 18 years of age and older must complete the SafeSport curriculum within 30 days of activating their USEF membership in order to be eligible to compete at a USEF recognized show. You can access the SafeSport modules from your USEF member dashboard at <a href="https://www.usef.org">www.usef.org</a>

All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at <a href="https://www.usef.org">www.usef.org</a>.

All questions not covered in these rules and regulations shall be decided by the show management whose decision shall be final.

Every horse entered for competition will comply with the rules of the horse show management, but management will, in no case, be responsible for any loss or damage that may occur, and it shall be condition of entry that each exhibitor shall hold this horse show and the officials and employees of the show blameless for any loss or accident to his horse, employees, equipment, which may occur from sickness, fire or otherwise.

The management reserves the right to refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit entries and cancel award prizes without claims for damages; to cancel or combine unfilled classes, or to reschedule classes after due notice to exhibitors; to change rings or rotate judges.

Exhibitors are notified that any act of discourtesy or disobedience to the judges or officials, on the part of the owner, manager, rider, or groom shall disqualify the horse, and the owner shall forfeit his entry fee and other fees.

Show management reserves to itself the power to prohibit any person from attending or showing a horse in the ring and to remove any groom or horse from the show without being liable for compensation.

No person will be allowed in the show ring during the time of judging except the exhibitor and those having official or requested duties to perform.

It is the tradition of the show that riders be correctly attired for the class in question, that attendants be neatly dressed, and the horses properly presented. Management may in its discretion bar any person from entering the ring if not suitably presented to appear before an audience. Please refer to Annex A of the USEF Rulebook for information about appropriate tack, saddlery and dress.

NEW RULES EFFECTIVE 12/1/2023: All horses must have USEF Horse Identification or USEF Horse Registration. In the past only a USDF Horse ID was required, but now a USEF Horse Identification or USEF Horse Recording (Annual or Lifetime) is also required. In addition, DR121.9 - Bridle Numbers. Competitors may use their own numbers for schooling and competition, but they can't skip check in with the show office because they don't need to pick up a number. Failure to check in at the show office prior to schooling will result in the issuance of a Warning Card.

### 2024 Great American Insurance Group/USDF Regional Dressage Championships



A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at <a href="https://www.usdf.org">www.usdf.org</a>. Please refer to the 2024 USDF Member Guide for the comprehensive list of rules and requirements for this program.

#### Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

#### Rider:

- Must have a USDF Participating\* Membership (PM).
- Must have a USEF membership (Active or Life).

#### Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse Recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s). A horse is not required to have breed registry papers.

#### Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Active or Life Membership or Annual or
  Life Recorded Farm/Business). If the horse has more than one owner, at least one owner must have both active USEF
  membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF.
   For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both
  USEF and USDF.
- \* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

**Minimum Qualifying Scores:** One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider. FEI Junior and FEI Young Rider classes have only one respective division.

## EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.

GR845 Equine Vaccination Rule 1. At Federation licensed competitions, horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Documentation should consist of one of the following methods mentioned below. The frequency of vaccine administration should be per the vaccine manufacturers' or veterinarian's recommendations. It is recommended that vaccines are administered by or under the direction of a veterinarian. 2. In the case of vaccines administered by a veterinarian, the exhibitor, upon request by Competition Management, must provide documentation from the veterinarian on documenting that the horse in question received the vaccinations; name of the vaccines and date of vaccine administration. 3. In the case of vaccines administered by a person other than a veterinarian, the exhibitor, upon request by Competition Management, must provide a receipt of the vaccine purchase which is signed by the owner, or agent with care, custody, and control of the horse; name, serial number and expiration date of the vaccine; and date of vaccine administration. 4. In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, the exhibitor, upon request by Competition Management, must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns and a log of temperatures taken twice daily for the seven days prior to entering the competition grounds. These horses must also have their temperature taken and logged twice daily while on the competition grounds. The log of temperatures should be provided to the Competition Management, steward, or technical delegate when requested. 5. Competition Management may not amend or enhance vaccination requirements without prior approval of the Veterinary Committee. Effective 12/1/15.

Helmet Policy: Current USEF helmet policy will be strictly enforced.

Sharps Containers: Competition management shall place a minimum of one sharps container per each competition, whether or not stabling is provided. Additionally, at least one sharps container per fifty occupied stalls for the disposal of needles and other disposable sharp instruments in convenient locations in barns housing competition horses. It is competition management's responsibility to replace such containers when full and dispose of them properly. Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments. If local law has different requirements, local law will prevail.

#### Motorized Vehicle Statement in accordance with GR1301.7:

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above-described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

#### Motorized Vehicle Statement in accordance with GR1301.8:

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

#### **USEF MEMBERSHIP STATEMENT**

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above, Combined Driving Competitions at the Advanced Level, Dressage Competitions, Endurance Rides and Vaulting Competitions: (See GR828.4 of the Federation rules). Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR231) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

## **USDF** Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of individual members and over 100 independent organizations throughout the United States, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

#### **Exceptions:**

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those
  sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at
  Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are
  exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot,
  academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM
  identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

#### Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

**Group Membership (GM):** A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program and the USDF Regional Schooling Show Awards Program. **Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$115) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:
